Dear Attorney General Uthmeier,

I have previously contacted Polk County Sheriff Grady Judd, the Sumter County Sheriff's Office, the Citrus County School Board, Sumter County School Board, Senator Rick Scott's Office, Florida Governor's Office and others. I have received only one response regarding my concern for child predators being assisted by State of Florida school administrators providing these predators unfettered access to Florida children.

My futile requests have garnered but one inept response. Sheriff Grady Judd wrote back on, January 6, 2025, suggesting I contact the Sumter County Sheriff's Office, which is where my ordeal began in the first place.

My request to you is the same as my previous request to Polk County Sheriff Grady Judd as quoted here:

"I am writing this plea for your help with the hope that you are not hobbled by The Villages/Morse Family sphere of influence. Please, carefully examine the enclosed documentation."

My wife and I relocated from California to The Villages, Florida, June of 2023. Then, in 2024, we were coerced into leaving the state of Florida for our own safety. Thus, November, 2024, we moved to Texas. The following information communicates our firsthand examples of what we experienced as residents of The Villages, Florida.

We (the Toledos) have assimilated that, if, and when, a "FAMILY" controls at least 50 square miles of Florida "development" property, the "FAMILY" can easily influence corrupt bureaucracies, the governing of businesses, home owners, residents, politicians (at all levels), law enforcement, school boards, members of entire school administrations, faculty members, news media, the lives of fearful parents and their children, etceteras.

Thus, in turn, if the "FAMILY" so chooses, corrupt members can maliciously wield their uninhibited POWER and unlimited INFLUENCE to SILENCE citizens who dare voice "unpleasant" facts of which the "FAMILY" makes the determination should never see the light of day and never enter the public domain.

In my case, the "FAMILY" is attempting to silence my "child endangerment" whistleblowing because "FAMILY" members have deemed my "child endangerment" facts to be interpreted as "negative publicity" for the "FAMILY" enterprise. Keep in mind, to this day, the "FAMILY" has never stated that my "facts" are not legitimate, it is simply that the "FAMILY" does not want my firsthand "facts" to go public as LAW enforcement cows to the "FAMILY."

Below is a "frame capture" from a Sumter County Sheriff's Office promotional video in which Bill Farmer, then, Sumter County Sheriff states, **"If you see something say something and I promise we will do something."**



Here is a significant fact: On **March 14, 2024**, I was assaulted at H.G. Morse Stadium, The Villages High School, Middleton, Florida, by a man who stated to me: **"The Villages does't like negative publicity."** Those are the exact words of the verbal "message" relayed to me by my still unidentified assailant, who had just finished phone conversations with administrators of The Villages High School prior to relaying his threatening comments to me.

Shown below is a reasonable facsimile of the still unidentified man who assaulted me and attempted to pilfer my personal property in Middleton, at The Villages High School's H.G. Morse Stadium, March 14, 2024:



Having lived through this terrorizing experience, I can now more closely relate to parents, showing up at school board meetings across America, who are called terrorists and falsely charged with crimes at the behest of school administrators, just for not wanting pornography in their children's classrooms. I have experienced that telling the truth and exposing fraud in Florida has become a revolutionary act. In this state, Florida, as in California, trusted "overseers" are in opposition to the safeguarding of the very children for whom they are accountable to protect.

Since this incident, several local longtime Floridians cautioned me to be aware of the entity these Florida natives refer to as the "Morse Mafia." I had never heard the "Morse Mafia" terminology before these alarming warnings to me. I had already encountered parents of students attending The Villages High School who were thoroughly intimidated by fear of a perceived threat their children could be rejected by this "privileged" education apparatus.

THIS IS A POWERFUL "CULT" THAT CANNOT BE QUESTIONED AS IT IS IN DIRECT OPPOSITION TO FREE SPEECH, PARENTAL RIGHTS AND CHILDREN'S SAFETY.

On **March 1, 2024**, I wrote the following statements to **Dr. Randy McDaniel**, The Villages High School Director of Education: "Any student in the State of Florida, participating in pole vault, while applying FHSAA approved lethal pole vault methods, is in REAL DANGER." Additionally, I wrote: "At the root of this deadly predicament is the sports equipment Goliath, UCS (United Canvas & Sling). Thirty-three years ago I entered the belly of this beast as it was metastasizing into the malevolent monster it is today."

More than three decades ago, I first became aware of the child predation structure of which I am still attempting to expose. This is a conscienceless monster with tentacles that grip administrators of nearly every high school and college in America. Dr. Randy McDaniel, The Villages High School Director of Education; Robin Grant, The Villages High School Principal; and Richard Pettus, The Villages High School Director of Athletics, are prime examples as to the extent of this child endangerment enigma.

These are cunning predators who have learned to remain at the outer edges of official school systems and apply their ill-gotten influence within the process of persuading schools to provide them access to children outside of school campuses. Using this stalking technique, the predators are granted full off-campus access to their clueless child prey with the full knowledge and assistance of school authorities. The "overseers" can then "wash their hands" of any form of "accountability" for the various child endangering activities in which they collude.

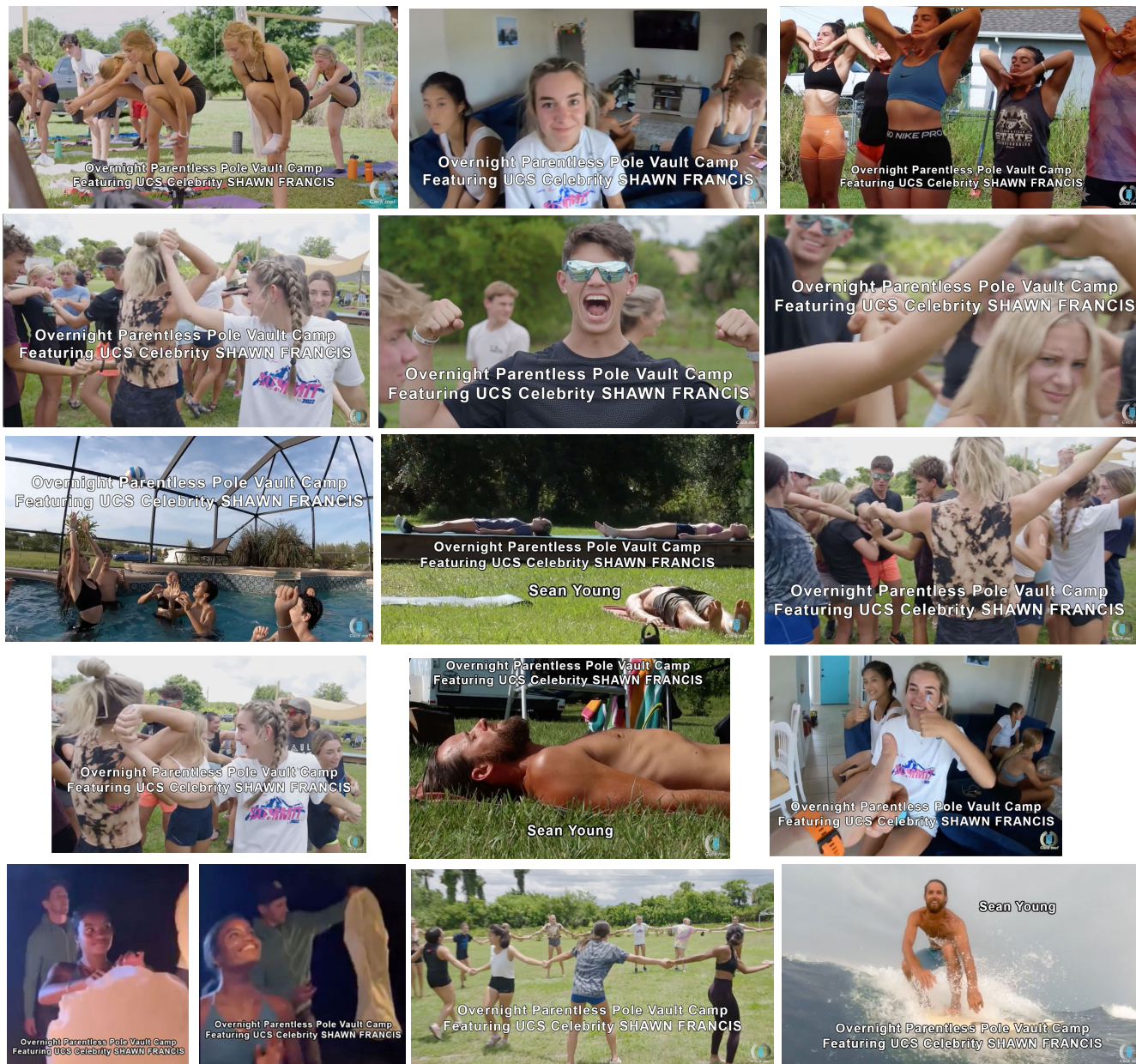
Since I discovered their existence in Florida, I have been trying to expose what are described as "Central Florida Pole Vault Sleep Away Camps." These "Camps" intermingle adolescent girls and boys ranging from minor status (14 to 17 years of age) together with adults (18 & 19 year-olds) of both sexes. These "parentless pole vault camps" consist of 4 days & 3 nights without parental supervision.

The coeducational AGE REQUIREMENT is "**14-19 ONLY**" with the stipulation that "**no parents are allowed.**" Regardless, whether attendees are classified as **minors or adults**, bedding down in the camp's "giant girl tee pee" and "giant boy tee pee" is not mandatory. NOTE: The "**What to bring**" list contains the option, "**Tent (if you would prefer to use your own tent)...**" Thus, the young "campers" are provided options as to where each might choose to retire for the night, regardless of age or gender.

One of the most blatant adult child predators I've encountered is 40 year-old, Shawn Francis. I have observed

Francis expand his child endangering influence for more than a decade. In this example, collaborating with Sean Young (Florida businessman), Shawn Francis fearlessly displays his child influencing talents in the promotional “Parentless Pole Vault Camps” video at this link: <https://www.youtube.com/watch?v=BBOFpHTewSc> – In this Sean Young promotional video, Shawn Francis laughingly refers to “penis” drawings created by minors attending Young's Florida “camps.” Simultaneously, in the same video, Francis blatantly deprecates parental authority.

Shown below are images captured from the video at the preceding link:



That is Shawn Francis, pictured in the background of the two lower left images above, as Francis himself was mingling with the children of parents who are not allowed to attend the same “camp.” It is also Shawn Francis' wristwatch shown in the thumbs-up image just above the photo of Sean Young surfing during the “camp” (lower right). It is evident, in the above images, that select influential adults are welcome “inside” while parents are not.

As to teaching any of these young boys and girls “pole vaulting,” there is very little evidence in this video of any vaulting instruction. The fact is, any pole vault teachings recorded being taught to these young students, are only

the same wrong-way injurious methods that have been promoted by United Canvas & Sling for many decades.

Note that, while children's parents are restricted from admission into the exclusive \$1000 per student Sean Young overnight Florida “Parentless Pole Vault Camps,” predator Shawn Francis, is provided 24-hour access to physically mingle with, and video record, the juvenile male and female children of the parents who are prohibited from attending and supervising.

Also, please, do not overlook the fact that these Sean Young “Parentless Pole Vault Camps” **are being openly condoned, protected and promoted, by schools and school boards throughout the State of Florida.** This begs the question: Why are these entities exerting effort to cover up such abhorrent activity targeting minor children?

I'm pointing out only a very few examples, there are easily hundreds. Francis has been luring minors into this child influencing cult for well over ten years, applying the Youtube video platform as well as other forms of social media. One technique Francis utilizes to attract his juvenile audience, is to alter his voice into that of a child.

Shortly after the start of the video I am referencing here (<https://www.youtube.com/watch?v=tOVZqKiW06Y>), approximately 01:12 seconds in, Francis laughingly tells his young viewers (comprised mostly of minor boys and girls) a “Herpes” joke. Applying Francis' technique of altering his voice to sound like a child, Francis proceeds to tell a story featuring a **young boy who has sex with his babysitter and a Herpes infected prostitute.**

Francis ends the same video vlog presentation, with recorded excerpts of his visit to a “drag” nightclub. Known as the Gay90s, Francis emphasizes to his underage video fans, that he frequently visits this nightclub. In his own words, Francis proudly states the Gay90s is **“one of the most fun places I've ever been my entire life.”**

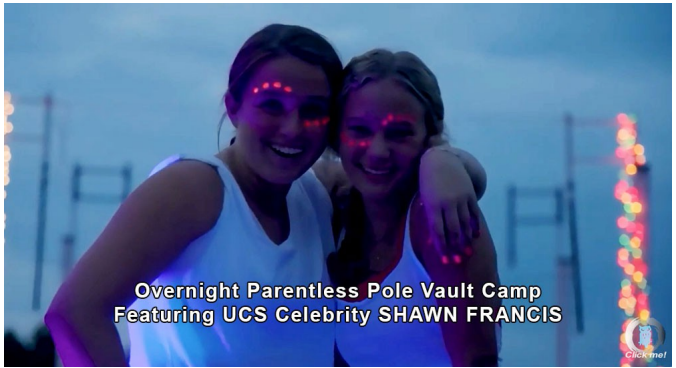
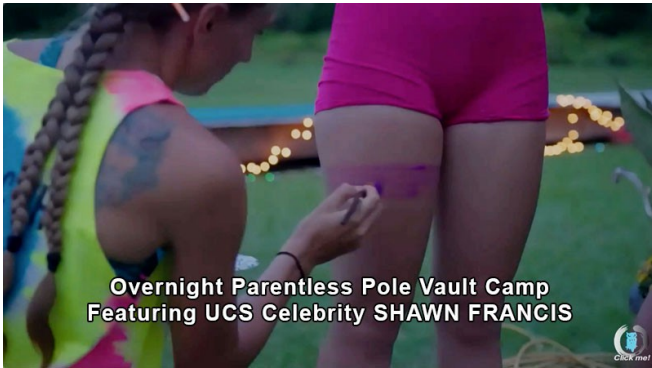
In his Gay90s video clip, Shawn Francis' friend's dad, Roger, ends up with the drag queen on his lap. Shawn Francis explains: “The drag queen goes, 'Hey, you look pretty uncomfortable.’” Francis pauses, while laughing, “Not as uncomfortable as me, cause **I'm the one sitting on my own penis.**” Francis laughs hysterically.

The first set of images is comprised of a Gay90s.com webpage advertisement depicting florescent body painting together with images of the children recorded by Shawn “Hoot” Francis, at Florida businessman Sean Young's overnight “Parentless Pole Vault Camps.”

The combination of images on the following page should strike any parent (but particularly those parents banned from attending their own children's “camps” for which they have paid) as a bit “disconcerting,” at the very least:

“Drive wedges between parents and their children” (Dr. Ben Carson, 2024, communist objectives in America)

Below left is a image captured from a Shawn Francis video published for children, in which Francis remarks, “My favorite towel ever.” The center-left image shows Francis wearing his “favorite towel.” In the image at center-right Francis’ choices, to which Francis is referencing, are depicted. The image on the far right displays the moment Mr. Francis informs his minor audience where to “get” the towels he is promoting to them at “DickTowel.com.”



Shown next is a image captured from the Shawn Francis video he produced for his friend, Florida businessman Sean Young, promoting Young's overnight Florida “Parentless Pole Vault Camps.” In this video, Shawn Francis states with glee, “Some people drew penises...” while he follows up with, “I woodah done the same thing.”



The three images in the below left montage display the deadliest of all lethal pole vault miseducation methods being sold by Florida businessman Sean Young... the "BULL-PUSH." My son, Chris Toledo, is also pictured below, in 1992, performing this same DEADLY METHOD of pole vaulting. Ten years later, Kevin Dare, pictured to the right of my son, was killed during a nationally televised track meet while attempting the same "wrong-way" lethal stupidity sold by Young and Francis. In 2015, female Austrian championship pole vaulter, Kira Grunberg, was permanently paralyzed executing the same deadly miseducation displayed by her in the far right image.



NOTE: Only days prior to Kevin Dare's needless death, in 2002, caused by a preventable fatal head injury, 16 year old **Florida high school pole vaulter, Jesus Queseda**, was also needlessly killed in the same manner. At the time, ESPN published that, prior to Kevin Dare's death, Queseda's "death didn't even cause a ripple in the national news." In other words, Jesus Queseda's pole vault death **would have never been noticed** had it not been for the televised DEATH of KEVIN DARE. Both of these teenage deaths were completely preventable!

Without a doubt, Shawn Francis, Sean Young and other members of their insidious cult, are far more concerned with the level of financial income they each derive from their child related schemes than they are for the safety of the children with whom they explicitly interact. In their vile realm, this stratagem is the RULE not the exception:

- **WHAT** do Sean Young's overnight Florida "Parentless Pole Vault Camps" actually accomplish?
- **WHO** does Sean Young's overnight Florida "Parentless Pole Vault Camps" actually benefit?

The image you see (below) of Florida Pole Vault Rentals and Sky Pole Vaulter Elite Athletics proprietor, Sean Young, standing in the middle of more than one-hundred vaulting poles, was recorded at what appears to be a State of Florida high school or college facility to which there is only privileged "OFFICIALLY" approved access.

- Which "OFFICIAL" organizations and institutions are behind the approval of Sean Young's ACCESS to RESTRICTED facilities?
- How is it that Mr. Young is welcome to provide his deadly vaulting poles to high schools and colleges, throughout the State of Florida, without scrutiny or inhibition?



Keep in mind that, excluding additional very expensive shipping rates, today's vaulting poles are sold for an average price exceeding \$800 apiece! There are more than 125 poles in the Sean Young Florida Pole Vault Rentals photo above. The mathematics is self-evident: 125 times \$800 is \$100,000, plus \$1000 per child for "parentless" 3-night "pole vault camps." **Do these dollar figures provide a clue to divulging one of this cabal's primary motivations?** Mr. Young also boasts, in his promotions, that his "NON-PROFIT ORGANIZATION" maintains an inventory exceeding 500 poles. 500 times \$800 is \$400,000 in vaulting pole inventory alone! You can be certain, child safety is not paramount among the incentives of these child exploiters... MONEY IS!

Sean Young, proprietor of Florida's Sky Pole Vault Elite Athletics, does not shy away from conning parents into forking over \$1000 per child for Young's summer "PARENTLESS" 3-night "pole vault camps." Again, keep in mind that these so-called "pole vault camps" are mingling 18 & 19 year old teenagers, of both sexes, with 14 to 17 year old MINOR teenagers of both sexes. Once the YOUNG marks have been securely "corralled" (away from their parents) they are absolutely vulnerable easy prey.

Appearing to be focused on STUDENT WELFARE, there are authorities who pretend to soil their underwear at the frightening thought that a water pistol might be discovered on school campus, while the same authorities are welcoming into school districts, with open arms, CHILD PREDATORS who fearlessly reveal themselves in plain sight. As evidenced in just the few examples you have already seen here, these hideous creatures are being publicly embraced by institutions across America, which increasingly serves to embolden the twisted souls who will continue INFLICTING their devastating intentions upon naive children and gullible parents without remorse.

I will repeat here, a quote from Shawn Francis publicly boasting during a podcast interview, in which Mr. Francis reiterates that the PRIMARY RULE relating to the children at the \$1000.00 PER CHILD Florida Sky Pole Vault Elite Athletics CAMP is: **"No parents are allowed, not even at the end. They can only pick 'em up."**

My firsthand experiences and evidence confirm that child endangerment is being openly condoned by authorities who are simultaneously exerting great effort to PREVENT PARENTS from hearing the sound of my exhausting "alarm calls" which are obviously intended to PROTECT easily influenced children from contemptuous predators.

After more than 34 years of opposing this derelict cabal, it is clear to me that, rather than choosing to do the RIGHT THING, those who abdicate responsibility are now willing to go so far as to "kill the messenger" in order to benefit themselves while they maintain their allegiance to a corrupt long-lived "Status Quo."

This malevolent cabal opposes free speech and free thought as its members attack anyone who might pose any risk of exposing their malicious intentions. Members have little or no desire to communicate with common sense everyday citizens. These miscreants expend their energy strictly to "protect their own" while openly cultivating avoidable risks that jeopardize defenseless child prey. My purpose is to expose this cult's anti children antics.

Free speech is a God-given right guaranteed by our Constitution. I will keep speaking out until someone in charge does their job and admits to parents, "the school system is in trouble." The "system" needs the attention and care of its leaders. We desperately require people who actually want to protect the children instead of the mental invalids who are trying to thwart my mission to reveal preventable perils threatening innocent children.

It is simply the right thing to do.
