
Established on a **"risk to the user per application"** basis, misused flexible vaulting poles transform into one of **the most lethal weapons ever developed** by human hands. In 1991, ELEVEN YEARS PRIOR to a teenage pole vaulter plummeting to his death during a nationally televised track meet, it had already become thoroughly obvious to me that EXCESSIVE RUNNING SPEED & BULL-PUSH are the primary avoidable sources causing the transformation of flexible vaulting poles into **DEADLY WEAPONS**.



The MISeducation is rooted within the 60 year-old Browning Arms ad you will see on the following page.




At take-off the vaulter using a metal pole follows a nearly true arc. The change of direction of the vaulter is severely abrupt at the very start of the climb and most of the climb must take place before the pole is half way between its starting point and vertical. Much of the momentum of the run and take-off is lost through the severe jar as the pole meets the box.



WITH THE SKY POLE PERFORMANCE IS UNIFORM

with every vault irrespective of temperature or other climatic conditions. Neither the age of the pole nor the amount of use it receives alters performance. It will not corrode, become misshapen, or deteriorate in any way. With good care it will last year after year. Only the type of sharp blow that would fracture some of its glass fibers can damage a Sky Pole.





With the Sky Pole, much of the vaulter's forward momentum is absorbed in the Sky Pole as it bends. The vaulter's initial climb is less abrupt and thus much smoother. Then as the Sky Pole reaches a 60° angle it starts thrusting the vaulter up with the momentum it has stored.


