Dear Sheriff Judd,

I am writing this plea for your help with the hope that you are not hobbled by The Villages/Morse Family sphere of influence. Please, carefully examine the enclosed documentation.

I have contacted the Sumter County Sheriff's Office, Citrus County School Board, Sumter County School Board, Senator Rick Scott's Office, Florida Governor's Office and others. I have received no response from anyone with regard to child predators being assisted by Florida school administrators providing unfettered access to children.

My wife and I relocated from California to The Villages, Florida, June of 2023. During the time of our stay, we were coerced into relocating from Florida. We moved to Texas, November, 2024. The following information is intended to communicate firsthand examples of what we learned as residents in The Villages, Florida:

If, and when, a "FAMILY" controls at least 50 square miles of Florida "development" property, the "FAMILY" can easily influence corrupt bureaucracies, the governing of business, home owners, residents, politicians at all levels, law enforcement, school boards, school administration members, faculty members, news media, the lives of fearful parents and children, etceteras.

Thus, in turn, if the "FAMILY" so chooses, corrupt members can maliciously wield their uninhibited POWER and unlimited INFLUENCE to SILENCE citizens who dare to voice "unpleasant" facts of which the "FAMILY" makes the determination should never see the light of day and never enter the public domain.

In my case, the "FAMILY" is attempting to silence my "child endangerment" whistleblowing because "FAMILY" members have deemed my "child endangerment" facts to be interpreted as "negative publicity" for the "FAMILY" enterprise. Keep in mind, to this day, the "FAMILY" has never stated that my "facts" are not legitimate, it is simply that the "FAMILY" does not want my firsthand "facts" to be exposed to the public.

Here is a significant fact: On March 14, 2024, I was assaulted at H.G. Morse Stadium, The Villages High School, Middleton, Florida, by a man who stated to me: **"The Villages doesn't like negative publicity."** Those are the exact words of the verbal "message" relayed to me by my still unidentified assailant, who had just finished phone conversations with administrators of The Villages High School prior to relaying his threatening comments to me.

Shown below is a reasonable facsimile of the still unidentified man who assaulted me and attempted to pilfer my personal property in Middleton, at The Villages High School's H.G. Morse Stadium, March 14, 2024:



Having lived through this experience, I can now more closely relate to parents, showing up at school board meetings across America, who are called terrorists and falsely charged with crimes at the behest of school administrators, just for not wanting pornography in their children's classrooms. I have learned that telling the truth in Florida has become a revolutionary act and, as in California, the trusted "overseers" are in opposition to the safeguarding of the very children for whom they are accountable to protect. This powerful "CULT" cannot be questioned as it is in opposition to free speech, parental rights and children's safety.

On March 1, 2024, I wrote the following statements to Dr. Randy McDaniel, The Villages High School Director of Education: "Any student in the State of Florida, participating in pole vault, while applying FHSA approved lethal pole vault methods, is in REAL DANGER." Additionally, I wrote: "At the root of this deadly predicament is the sports equipment Goliath, UCS (United Canvas & Sling). Thirty-three years ago I entered the belly of this beast as it was metastasizing into the malevolent monster it is today."

More than thirty years ago, I first became aware of the child predation element of which I am still attempting to expose. The continuing problem, in my case, strongly involves United Canvas & Sling and its tentacles that grip administrators of nearly every high school and college in America. Dr. Randy McDaniel, The Villages High School Director of Education; Robin Grant, The Villages High School Principal; Richard Pettus The Villages High School Director of Athletics, are prime examples as to the extent of this child endangerment enigma.

Free speech is a God-given right guaranteed by our Constitution. I will keep speaking out until someone in charge does their job and admits to parents, "the school system is in trouble." The "system" needs the attention and care of its leaders. We need people who actually want to protect all children instead of the mental invalids who are trying to thwart my mission to expose needless dangers threatening vulnerable children. This is a cult that opposes free speech and free thought. They have little or no desire to communicate with common sense everyday Americans and I intend to expose their anti children antics. Status Quo does not want US to fix the problems THEY have intentionally created while THEY are clearly putting their energy into "protecting their own" and advocating preventable risks that endanger vulnerable children.

At the center of the "child endangerment" reality I am attempting to expose, is sports equipment Goliath, United Canvas & Sling. The UCS spirit of corruption is the source of exponential harm, both physical and mental, being initiated against children. UCS controls every facet of the "Deadliest Sport in America" while the MISeducation the company propagates has needlessly injured thousands, which includes dozens of preventable young deaths.

The UCS Spirit fiberglass vaulting pole manufacturing division, from its inception in 1987, has profited from lies, deception and blatant negligence. For example, the first fiberglass vaulting poles were actually the innovation of Virgil Jackson, Congressman Bob Mathias' high school coach, who provided one of his first poles for use by Bob Mathias during the 1950 National Decathlon Championship in Tulare, California. Yet, UCS, to this very day, has falsely claimed credit while, at the same time, knowingly concealing the TRUE facts from the public.

Another example of United Canvas & Sling's deadly deception and child predation is the company's relationship with Coach Shawn Michael Francis, in which there is unrestrained collaboration for the purpose of luring minor boys and girls into this so-called "Pole Vault Community" dominated by child predators.

If you think my accusations are far fetched, simply continue perusing the enclosed information and view the evidence that members of the "Pole Vault Community" publish "themselves" on video sharing platforms. Some of these predators, such as Shawn Francis (known to children as "HOOT"), have neither the need, or the desire, to enter employment in any school systems because, as teachers in schools, their anti children antics would be much more vulnerable to public scrutiny.

Thus, these predators have learned to remain at the outer edges of official school systems and apply their ill-gotten influence in the process of persuading schools to provide them access to children outside of school campuses. Using this stalking technique, the predators are granted full off-campus access to their clueless child prey with the full knowledge and assistance of school authorities. The "overseers" can then "wash their hands" of any form of "accountability" for the various child endangering activities in which they collude.

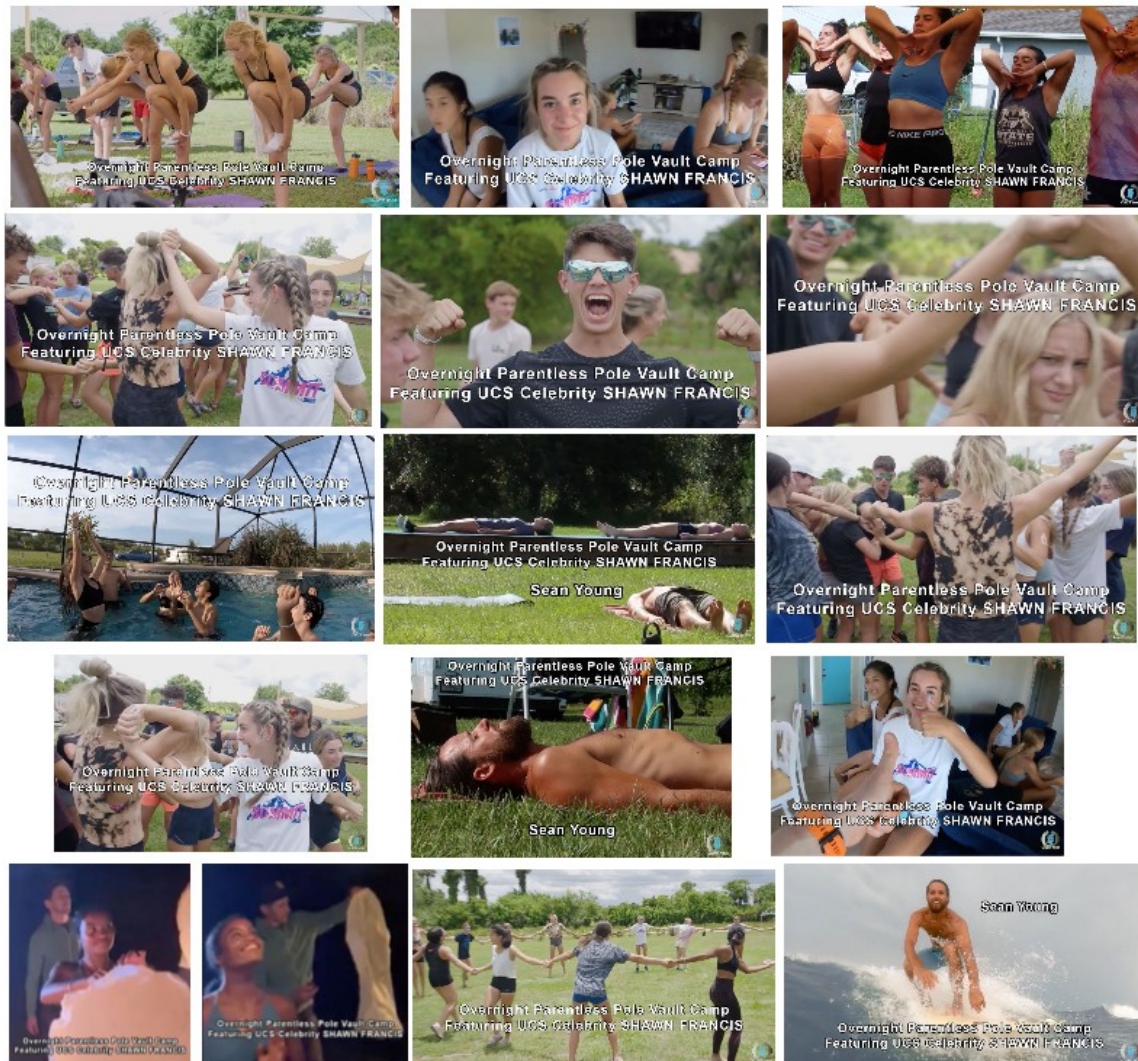
For example, since I discovered their existence in Florida, I have been trying to expose what are described as "Central Florida Pole Vault Sleep Away Camps." These "Camps" intermingle adolescent girls and boys ranging from minor status (14 to 17 years of age) together with adults (18 & 19 year-olds) of both sexes. These "parentless pole vault camps" consist of 4 days & 3 nights without parental supervision.

The coeducational AGE REQUIREMENT is "**14-19 ONLY**" with the stipulation that "**no parents are allowed.**" Regardless, whether attendees are classified as **minors or adults**, bedding down in the camp's "giant girl tee pee" and "giant boy tee pee" is not mandatory. NOTE: The "**What to bring**" list contains the option, "**Tent (if**



you would prefer to use your own tent)..." Thus, the young "campers" are provided options as to where each might choose to retire for the night, regardless of age or gender.

It is also Francis' wristwatch in the thumbs-up image just above the photo of Sean Young surfing during the "camp" (lower right). It is self-evident in the above images, that select influential adults are welcome while parents are not.

As to teaching any of these young boys and girls "pole vaulting," there is very little evidence in this video of any vaulting instruction. The fact is, any pole vault teachings recorded being taught to these young students, are only the same wrong-way lethal methods that have been promoted by United Canvas & Sling for many decades.

In the Sean Young "Parentless Pole Vault Camps" promotional video (referred to in the image above), published by UCS Celebrity, Shawn "Hoot" Francis, as he is known by his child victims, "Hoot" laughingly refers to "penis" drawings created by minors at these Florida "camps." Simultaneously, in the same video, this deviant adult blatantly deprecates parental authority.

Note that, while children's parents are restricted from admission into the exclusive \$1000 per student Sean Young overnight Florida "Parentless Pole Vault Camps," UCS Celebrity, Shawn Francis, is provided 24-hour access to physically mingle with, and video record, the juvenile male and female children of the parents who are prohibited from attending and supervising.

Also, please, do not overlook the fact that these Sean Young "Parentless Pole Vault Camps" are being openly condoned, protected and promoted, by schools and school boards throughout the State of Florida. This begs the question: Why are these entities exerting effort to cover up such abhorrent activity targeting minor children?

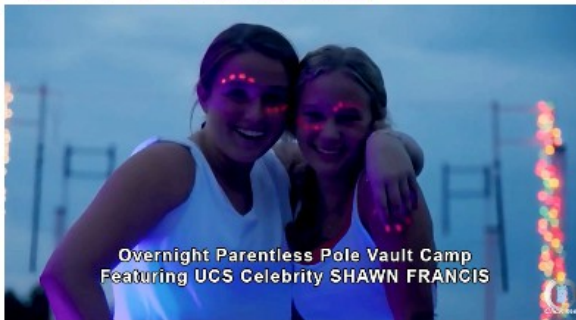
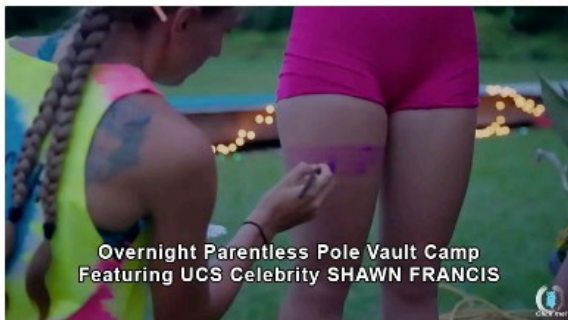
Shortly after the start of the video I am referencing (<https://www.youtube.com/watch?v=tOVZqKiW06Y>), approximately 01:12 seconds in, Francis laughingly tells his young viewers (comprised mostly of minor boys and girls) a "Herpes" joke. Francis proceeds to tell a story featuring a young boy who has sex with his babysitter and a Herpes infected prostitute.

Francis ends the same video vlog presentation, with recorded excerpts of his visit to a "drag" nightclub. Known as the Gay90s, Francis emphasizes to his underage video fans, that he frequently visits this nightclub. In his own words, Francis proudly states the Gay90s is "one of the most fun places I've ever been my entire life."

In his Gay90s video clip, Shawn Francis' friend's dad, Roger, ends up with the drag queen on his lap. Shawn Francis explains: "The drag queen goes, 'Hey, you look pretty uncomfortable.' Francis pauses, while laughing, 'Not as uncomfortable as me, cause I'm the one sitting on my own penis.'" Francis laughs hysterically.

On the following pages of this document, I've included images from the Gay90s website. The first set of images is comprised of a Gay90s.com webpage advertisement depicting florescent body painting together with images of children recorded by UCS Celebrity, Shawn "Hoot" Francis, at Sean Young's Florida overnight "Parentless Pole Vault Camps." This combination of images should strike any parent as "curious," at the very least.

Dear Sheriff Judd,

Your office received a packet, on Friday, January 3, 2025, sent by me via USPS Priority Mail. This email today is a follow up to the request and information in last Friday's mailing.

My effort is intended to expose the systemic child endangerment and child predation being propagated within school systems across Florida and the United States relating to the extent and purpose of the adult participants involved in openly practiced "pole vault" criminal negligence.

**This email is a reiteration and extension of facts pertaining to the coercion that ultimately forced my relocation from Florida to Texas under duress.**

The documentation in the packet your office received from me this past Friday, January 3, 2025, highlighted the relationship between adults, Sean Young (Mims, Florida) and Shawn Francis, resident of Minnesota, in which these adults video underage children, mostly females, while prohibiting those children's parents from accessing the \$1000 per child overnight "parentless pole vault camps" in which the minors are being video recorded.

Since my relocation to Texas, I've discovered and compiled further video images recorded by Minnesota's Shawn Francis in which Francis is being welcomed into Texas "vault camps" which target children. Again, following the same pattern as in Florida, the vast majority of the children are underage girls.

Viewing the clips comprising the video (linked in the next paragraph) you will see nearly 40 year-old Francis executing "selfies" in which he photographs himself together with extremely young minor girls who he has referred to before as, "human subjects." In these clips, Francis informs his young fans/victims that his "favorite towel ever" is the pornographic "DickTowel" while instructing his child audience where to purchase the same.

You will also see Francis' video clips relating to the Mims, Florida, overnight "parentless pole vault camp" to which he was invited by Coach Sean Young. Among other repugnant clips, you will see Francis refer to the size of his "penis" while also ensuring his minor audience, "Don't worry baby birds, I'll feed you."

Additionally, be prepared to see a shameless image of a bare-butt adult at a Las Vegas "Pole Vaulter" party, which Shawn "Hoot" Francis video recorded, participated and shared with his minor children social media followers.


