As a resident of The Villages, I wanted to inform you of my recent experience dealing with the "clearance" process to qualify as a "volunteer" high school coach in Florida, via the Citrus County School Board, which led me to discover some significant facts regarding the deadliest of all school sports events. I wrote to your Athletic Director, Richard Pettus, on January 3, 2024, regarding my concern for this subject but have never received a response.

I became seriously associated with the event of pole vault in 1991, when I was able to attend one of my son's practices at Bob Mathias Stadium, in Tulare, California, for the first time. I was horrified by the coaching negligence I witnessed. Soon after that, I was in contact with the Tulare Union High School Athletic Director. That is when I discovered two high school teenagers died in the United States, that same year, after both young men sustained fatal injuries misusing fiberglass vaulting poles. Coincidently, I also discovered that the first fiberglass vaulting poles were originally created for Bob Mathias by his Tulare High School coach. My earnest quest in discovering pole vault's needless deadly flaws and corruption began at that time. It's been a very long and convoluted journey that brought us here.

Many years ago, when I spoke to the father of Darin Ohnstad, 1983 avoidable teenage pole vault fatality, the phrase "There but for the Grace of God go I" penetrated my being. I am obligated to young Darin, and countless other innocent victims of this corrupt event, to expose the nefarious reasons why these needless tragedies are being allowed to persist. The primary reason these dilemmas continue unabated is that few people have the courage and tenacity to bring such disturbing issues into the light while leaving parents completely in the dark.

Every Athletic Director and parent in America, needs to be made aware of avoidable concealed hazards related to the most lethal event in school sports. Pole vault is the most hazard laden of any sports event endangering school children across our nation. While presenting the greatest hazards per participant, pole vault is also the most expensive sporting event per competitor. Simultaneously, while being the most lethal sports event, it is also among the most improperly, carelessly and irresponsibly taught events in children's sports to this very day.
