Senator Scott,

This letter is a request for your assistance in bringing public awareness to unique questionable circumstances I've encountered in The Villages, Florida, relating to what is described as the "Morse Mafia" by many residents.

Several months ago a photo of you, in The Villages, sitting at a table with a friend of mine appeared on the front page of The Villages Daily Sun newspaper publication. Seeing my friend with you reminded me that he might be able to assist me with his knowledge and experience as a influential resident of The Villages. My wife and I had relocated from California to The Villages, in recent months, and we had questions regarding The Villages High School. Upon contacting my friend, he suggested that I should reach out to Dr. Randy McDaniel, The Villages High School Director of Education. I proceeded to follow my friend's advice.

It turns out, contacting Dr. Randy McDaniel "opened a can of worms" that I never expected could exist within "The Villages/Morse Community." Our well intended purpose of bringing public awareness to the topic of "child endangerment" in Florida schools suddenly turned my wife's and my life into "HELL." Because of threats to our safety, my wife and I eventually decided to leave "The Villages/Morse Community" for the sake of our well being.

The compounded stress that we are experiencing is directly connected to the fact that, more than thirty years ago, we dared to speak out, in 1991, after witnessing our own son's near catastrophes in high school sports. It is a fact that school catastrophes are the consequence of flagrant negligence by school administration officials and sports equipment manufacturers. Because of our relentless mission to PROTECT ALL children endangered by preventable corruption, we are now victims of intimidation and threats by "The Villages/Morse Mafia" faction.

We expressly remain committed to our objective as I, and my wife, at the age of 76 years, had, long ago, already experienced firsthand the preventable maiming and deaths of teenage friends during the time of the Viet Nam War. This vulgar malevolence, particularly the salacious violation of juveniles as "sacrificial lambs," should never be ignored or condoned, and, certainly, never ALLOWED to be criminally "covered up" by "trusted" authorities.

For your confirmation, here is one example of our decades of firsthand experience: Dan Rodgers, pictured on the left below, is a 1964 graduate of Porterville High School in California. Dan was a squad leader and sergeant in the Vietnam War. To the right of Dan Rodgers (in the photo below), is Chuck Lewis, a 1966 graduate of Tulare Union High School, which is located 25 miles northwest of Porterville.



It is alleged that Porterville, California, sacrificed more young men in the Viet Nam War, per capita, than any city in the United States of America while Tulare's Viet Nam War "Fatality List" was not far behind that of Porterville.

My wife's brother, a 1960s United States Marine, graduated with Dan Rodgers from Porterville High School in 1964. As teenagers, my wife and I were Chuck's friends and classmates. The three of us graduated from Tulare Union High School in 1966. "Truth Social" CEO, Congressman Devin Nunes, graduated with our son from Tulare Union High School in 1991.

I joined the United States Air Force in 1967. During the years I served in the military, while a teenager myself, several of my high school friends senselessly perished in the Viet Nam War at the whims of the malevolent "Military Industrial Complex." As an example of this devastating malevolence, during the "Tet Offensive" (1968) the "company" in which Dan Rodgers and Chuck Lewis served lost 126 young soldiers in less than two hours.



The vile perversion, of ruthlessly ending lives while permanently maiming the innocent (mentally and physically) for the purpose of insatiable evil-intentioned self interest we have witnessed, as a consequence of the Viet Nam War, still thrives today in scholastic institutions across America and within an abundance of corrupt government entities with which I have attempted to communicate. This corruption includes what I have now encountered and am attempting to expose in the State of Florida.

I was one of many teenage PATRIOTS who served in the United States Armed Forces in the 1960s. Our military oaths bestowed upon us responsibilities which included the lives and well being of others "dependent" on our integrity, talent and dedication to duty. Today, at 76 years of age, more than ever before, I appreciate the blessings of living in America and will continue to defend their existence against corruption. At the age of 24, not long after my honorable discharge from the military, I was appointed as a local board member of the Selective Service System. In 1974, I completed my Graduate Gemologist In Residence at the Gemological Institute of America, in Santa Monica, California. Eventually, my primary occupation was owner and operator of collateral loan businesses (pawnshops) in California. Our businesses were well known for our impeccable reputation with law enforcement and customer respect. I was a Federal Firearms Licensed gun dealer in a profession that has always been intensely scrutinized by the Bureau of Alcohol, Tobacco, Firearms and Explosives.

My mission to expose injustices committed by criminals holding power for the ill-purpose of wielding despotism veiled by corrupt color of authority will remain intact, as my allegiance to GOD and COUNTRY is resolute.

I have submitted incriminating evidence to school officials, school boards, the Governor's Office of the State of Florida, Florida High School Athletic Association, Sumter County Sheriff's Office, among others, for the purpose of exposing "child endangerment." My warnings are being wholly and willfully suppressed by culpable parties.
