Dear Sheriff Farmer,

Below is a "frame capture" from a local Sumter County Sheriff's Office video in which you state, "If you see something say something and I promise we will do something."



I am writing in reference to a Thursday, March 14, 2024, "TRESPASS WARNING" issued against me by Sumter County Sheriff's Deputy, Charles Pivetz, who initiated my "TRESPASS WARNING" (Case# SCSOCAD028043) in the parking lot outside of The Villages High School's H.G. Morse Stadium. I have included for you (shown below) a reasonable facsimile of the man who malevolently summoned Deputy Charles Pivetz after assaulting me and attempting to pilfer my personal property:



My unidentified assailant, who Deputy Pivetz misleadingly describes as "the security officer at The Villages High School in Middleton, located at 2210 Dr. Randy McDaniels [sic] Way," to date, has never been named in any of the documents I've seen. I do not believe that the man who summoned Deputy Charles Pivetz during his assault on me is a school "security officer," particularly after never seeing any verification as to the identity of this person at all. My still unidentified assailant openly revealed that his phone call to the Sumter County Sheriff's Office, March 14, 2024, during which he labelled me as a "suspicious person" and "child molester," was executed by him as a "retaliatory" action he admitted was prompted by members of The Villages High School Administration.

After malevolently summoning Deputy Pivetz, the unidentified man I have described and depicted above, who assaulted me on March 14th, 2024, at H.G. Morse Stadium, The Villages High School, Middleton, with impunity, said exactly the following words to me, "**The Villages doesn't like negative publicity.**" After a brief pause, he continued by stating, "**You live in The Villages.**" My still unidentified assailant was clearly using his words as further intentional means of "threat" to my well being. He made it evidently clear that, when stating the words, "The Villages," he was referring to unidentified "persons" inducing his actions against me, which also include his intentional misuse of Sumter County Sheriff's Office resources.

Please, peruse my attached May 14, 2024 two-page letter, which includes thorough details describing the circumstances and depth of this situation. I've also included documentation I sent to members of The Villages High School Administration (three emails) together with a letter I mailed to the Sumter County School Board and a additional three-page document regarding ongoing local "child endangerment" sent to each. The information in this documentation is the catalyst generating the retribution of which my wife and I are being subjected.

Since this incident, several local old-time Floridians have cautioned me while alluding to the "Morse Mafia." I had never heard the "Morse Mafia" term mentioned prior. There is no serenity in discerning their disturbing choice of words as I have encountered parents of students attending The Villages High School who appear thoroughly intimidated by fear of a perceived threat their children could be rejected by this "privileged" education apparatus.

By his own admission, the unidentified man who assaulted me was collaborating with multiple "individuals" he referred to as "The Villages." These "individuals" would be included as those Deputy Pivetz was referring to (in my attached May 14, 2024 letter) when Deputy Pivetz stated to me and my wife, "they want me to trespass you."

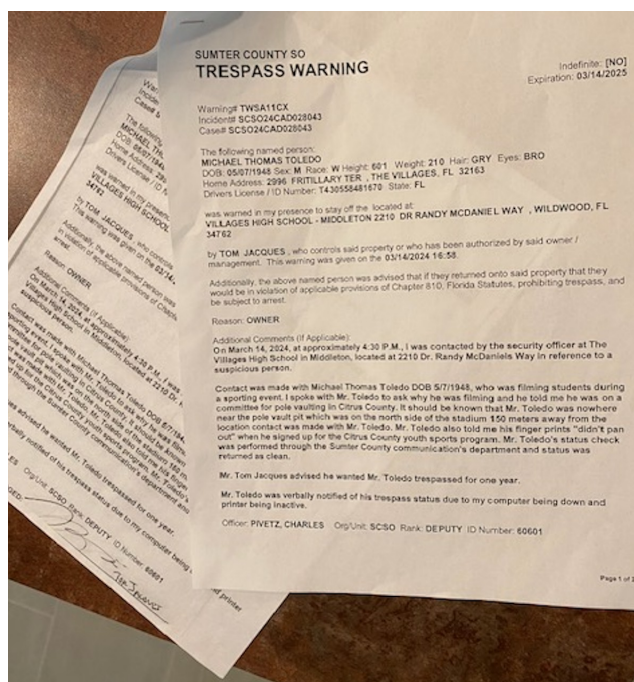
This begs the question: Who actually gave Deputy Pivetz the order to "trespass" me immediately prior to his return to our location in the parking lot on March 14, 2024, when he clearly intended to leave without issue?

Deputy Pivetz had driven away, then, immediately returned to state, "I apologize, but they want me to trespass you." Thus, within that matter of seconds, either Deputy Pivetz initiated contact with someone, or someone initiated contact with Deputy Pivetz as he was departing in his Sumter County Sheriff's Office vehicle.

Deputy Pivetz clearly states in his "TRESPASS WARNING" that he was summoned by "the security officer at The Villages High School in Middleton, located at 2210 Dr. Randy McDaniels [sic] Way..." Can you, or someone at the Sumter County Sheriff's Office, provide for me the identity of my assailant who Deputy Pivetz refers to as a school "security officer"?

Can you, or someone at the Sumter County Sheriff's Office, provide for me who it was that Deputy Pivetz specifically spoke to just before returning to inform me and my wife, "they want me to trespass you"?

I'm also asking if you would provide "Page 2 of 2" of the "SUMTER COUNTY SO TRESPASS WARNING"? In the copies presented to me at the Sumter County Sheriff's Office (shown in the image below) the "second page" I received is simply a duplicate copy of "Page 1 of 2" and not a actual copy of "Page 2 of 2."



Relating to the “TRESPASS WARNING,” it is significant that Tom Jacques, the person who volunteered to witness the “trespass,” did not arrive at the scene until after the “unidentified” caller had already notified authorities. Tom Jacques arrived while my “unidentified” assailant and I were waiting in the parking lot for Deputy Pivetz to arrive. Tom had no idea what was going on when he met me for the first time in the parking lot. After that, Tom went inside the fenced stadium area. The “unidentified” caller remained with me and departed later, leaving Deputy Pivetz and myself by ourselves in the parking lot. Tom came back after Deputy Pivetz and I had been left alone by the “unidentified” caller, who departed the scene several minutes earlier, before Tom returned. The “unidentified” caller did not appear again after he had departed.

Tom Jacques' physical appearance is nowhere near that of the man who assaulted me. Tom looked to be 6 feet 6 inches tall, clean-cut, more than forty years of age. I also believe Tom is officially a coach at The Villages High School, while the person who assaulted me and refused to identify himself is likely a school volunteer of some sort, not a “security guard.” The man who executed the “call” to the Sumter County Sheriff's Office was stoutly built, approximately 5' 10" in height, weighed at least 190 pounds and had a thick 3 to 5 inch beard. His age appeared to me to be in his late twenties but it was difficult to determine as his facial features were mostly covered and he was wearing wrap around mirrored dark glasses that hid his eyes.

Nearly all of the statements, recorded by Deputy Charles Pivetz, in the Case# SCSOCAD028043 documentation are completely false. An example: Deputy Pivetz blatantly lied when recording the following statement: “**Mr. Tom Jacques advised he wanted Mr. Toledo trespassed for one year.**” Tom Jacques was standing by our vehicle when Deputy Pivetz drove back to us and stated, “I apologize, but ‘they’ want me to ‘trespass’ you.” Tom Jacques was simply an innocent bystander who arrived after my assailant initiated this malicious collaboration of retribution. My assailant departed the scene long before Deputy Charles Pivetz proceeded to engage with filing or logging any of Deputy Pivetz' own falsified documentation.

An additionally shameless documented falsehood by Deputy Pivetz is as follows: “**the pole vault pit which was on the north side of the stadium 150 meters away from the location contact was made...**” This blatant falsity recorded in the Deputy Pivetz “TRESPASS WARNING” is eviscerated by the overhead image of H.G. Morse Stadium I've included below. The image verifies that the “pole vault” pits are NOT located on the “north side” of the football field as Deputy Pivetz falsely stated. The “pole vault” pits are (and always have been) located on the **south side** of H.G. Morse Stadium as you can see for yourself in the image below:



As to any of the reasons why Deputy Pivetz frivolously falsified information in his official "SUMTER COUNTY SO TRESPASS WARNING" is a mystery to me. It is baffling that Deputy Pivetz went so far as to state that my weight is "210" pounds. "210" is an exaggeration of more than 30 (thirty) pounds of my actual weight that day. Why would Deputy Pivetz falsify the documentation to this extent? Why did he falsify the information at all?

In the 1960s, I was one of many teenage PATRIOTS who served in the United States Armed Forces. The military bestowed upon us responsibilities which included the lives and well being of others "dependent" on our integrity, talent and dedication to duty. Today, at 76 years of age, more than ever before, I appreciate the blessings of living in America and continue to defend their existence against corruption. At the age of 24, not long after my honorable discharge from the military, I was appointed as a local board member of the Selective Service System. In 1974, I completed my Graduate Gemologist In Residence at the Gemological Institute of America, in Santa Monica, California. Eventually, my primary occupation was owner and operator of collateral loan businesses (pawnshops) in California, well known for our impeccable reputation with law enforcement and customer respect. I was a Federal Firearms Licensed gun dealer in a business intensely scrutinized by the Bureau of Alcohol, Tobacco, Firearms and Explosives!

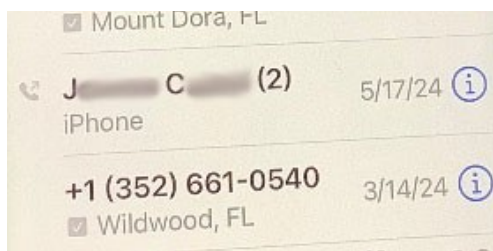
Prior to March 14, 2024, in 75 years, I had never before been assaulted. In 75 years, I had never before been referred to as a "suspicious person." In 75 years, I had never before been accused of "trespassing," etceteras.

Deputy Pivetz' inane references to "filming" are fabrications, as are his intentionally false references to "Citrus County" and his purposely deceptive references to "finger prints."

March 14, 2024, in The Villages High School parking lot, my still unidentified assailant clearly saw my wife sitting in our vehicle (exactly as you can see for yourself in the image below), yet, my assailant insanely persisted in the parking lot with his terrifying belligerent harassment and scurrilous accusations.



Shown below is the telephone number from which Deputy Charles Pivetz telephoned my wife when he invited her to return to The Villages High School parking lot after my assailant departed.



Because the topic of "child endangerment" is very significant to me, as I have mentioned in my prior futile attempts to contact responsible parties within the Sumter County School system, I am compelled to add that I have been trying to expose "Central Florida Pole Vault Sleep Away Camps" that intermingle adolescent girls and boys ranging from minor status (14 to 17 years of age) together with adults (18 & 19 year-olds) of both sexes. These "parentless pole vault camps" consist of 4 days & 3 nights without parental supervision.

The coeducational AGE REQUIREMENT is "14-19 ONLY" with the stipulation that "no parents are allowed." Regardless, whether attendees are classified as minors or adults, bedding down in the camp's "giant girl tee pee" and "giant boy tee pee" is not mandatory. NOTE: The "What to bring" list contains the option, "Tent (if you would prefer to use your own tent)..." Thus, the young "campers" are provided options as to where each might choose to retire for the night, regardless of age or gender.

These "camps" are being openly condoned and protected by high schools and school boards throughout the State of Florida. Why are these entities going out of their way to cover up this abhorrent behavior?

The attached 3-page document I've included, shows grotesque images of Florida "camp" promoter, 38 year old Shawn Francis. This adult deprecates parental authority while laughingly referring to "penis" drawings created by minors at local Florida "camps."

When my wife and I visited the Sumter County Sheriff's Office, located at 7361 Powell Road, Wildwood, Florida, on July 11, 2024, we also discovered that the "SUMTER COUNTY SO TRESPASS WARNING" (CAD028043) was NOT LIMITED to one year as stated. We discovered that Deputy Pivetz neglected to "check the box" to set the "one year" limitation, which caused the clearly falsified "TRESPASS WARNING" to be in force forever.

Again, I'll take the liberty to quote you, Sheriff Farmer: "The Sumter County Sheriff's Office is founded on the principles of integrity, respect, honesty, and caring for others."
